A. Juvenile Hall inspection debrief Dana, Kathy, Tori

Dana and Tori reflected about the need for more staff and beds in hospitals to help the kids in juvenile hall when they are unstable. She spoke about the need for mental health support and wondered how the commission can advocate for these kids. Spoke about how there is room for improvement in the use of chromebooks in juvenile hall. Alexa spoke about going to other organization meetings to share ideas and learn from others. The snapshot showed 1 girl and 9 boys currently in residence at Juvenile Hall.
