- Conservator is ordered to file the Sixth Account for the period 10/1/24 9/30/26 by December 9, 2027.
- 2. A hearing shall be set for January 20, 2028 at 1:30 for <u>either</u>.
  - a. Hearing on the Sixth Account; or
  - b. Explanation as to why it was not timely filed.
