(*Lopez v. Watchtower Bible & Tract Society of New York, Inc.* (2016) 246 Cal.App.4th 566, 604.) Furthermore, the Court recognizes that a terminating sanction is a "drastic measure which should be employed with caution." (*Deyo v. Kilbourne* (1978) 84 Cal.App.3d 771, 793.) Such a sanction is not warranted based on the facts presented.
