NATURE OF PROCEEDINGS: REVIEW HEARING – CHILD CUSTODY/VISITATION

#### **RULING**

This matter first came before the court on Petitioner/Father's Request for Domestic Violence Restraining Orders, filed April 17, 2024. At the hearing on May 8, 2024, the court issued restraining orders protecting Father and the parties' two minor children, referred the parties to Family Court Services (FCS) for child custody recommending counseling, and set the matter for hearing on June 5, 2024 on the issue of custody and visitation.

Neither party appeared for their scheduled appointment with FCS, and on June 5, 2024 the parents were re-referred to FCS.

Based on the information before the court, and having considered the declarations filed by the parties, it appears that the best interests of the minor children, Michelle and Jack, will be served by the court adopting the recommendations of Family Court Services (FCS), as set forth in its report issued on July 16, 2024, and as modified by the court. The court will do so, and the parenting plan is set forth below:

All prior orders not in conflict with the below shall remain in full force and effect with the following modifications:

- 1. Father shall continue to have sole legal and physical custody of the children.
- 2. Father shall not be under the influence of any non-prescription drugs while the children are in his custodial care.
- 3. Both parents shall take a domestic violence class to learn about the impact of domestic violence on children.

- 4. For a period of 2 months, Mother shall have supervised visits with a nonprofessional supervisor such as a family member or friend on either Saturday or Sunday for a day visit from 9 AM to 7 PM. Father shall cooperate with getting these visits started. If there have been no issues with these visits, Mother's visits shall transition to unsupervised visits, as set forth below.
  - a. Once Mother completes a domestic violence class and has completed 2 months of successful supervised visits, the children shall be in her unsupervised custody each weekend from Friday after work through Monday morning (or Sunday evening if Mother cannot exchange on Monday morning due to work obligations).
  - b. Once this schedule (Friday through Monday morning) has been in place for another two months, the schedule shall transition to a 2/2/5 schedule, and the children shall be with Mother every Monday morning until Wednesday morning, and with Father every Wednesday morning until Friday morning, and the parents shall alternate weekends (Friday morning until Monday morning).
- 5. Neither parent shall expose the children to domestic violence.
- 6. Father shall not verbally abuse Mother or call her derogatory names in the presence of the children.
- 7. Michelle shall be assessed by a therapist to see if she is old enough to benefit from therapy, as she is reported to have witnessed domestic violence.
- 8. This matter is continued to October 23, 2024 at 9:00AM in Department B for custody review.
- 9. By October 16, 2024, each parent shall file and serve a declaration to update the court regarding the status of each parent's compliance with the orders herein.

As authorized by Rule 5.125 of the California Rules of Court, the court shall prepare the formal order after hearing.
